






# Demographics for JJ Youth Cases Filed





---

We are sending JD, JS, JM, TRF cases to the portal.

We are only sending information on those people with a role of **Defendant** in these case types.

We have adults with the wrong role in the case which is causing us to have adults in the portal. We only want to send children information to the portal.

In a JJ case, the child is a Defendant and if you are adding the Parent/Guardian/Custodian to the case because they owe fees, they are the Responsible Party

For the D&N cases we are sending information to the Portal for anyone with a Role of **Child**.

We have adults with the wrong role in the case which is causing us to have adults in the portal. We are only sending children information to the portal.

In a D&N case, you normally have Children and Respondents.

If DCS is not the Petitioner, you may have a non-agency person, a grandmother for example, as the Petitioner listed here.

Agency people such as DCS, GAL, PO, YSO, are never listed here as Petitioner but in the Names Assigned section as Petitioner.

# Finding Open Cases

---

There is a new report in Quest called **“Cases open where everyone is over 18”**

You can run the report on specific case types.

This is another way to find old cases and possibly close them.

# Open for Collections

---

Because cases that have open fees can be open for years, we modified the case status that means open for collections to an “inactive” case status. This means for portal purposes that the case is closed but the case remains open in Quest so documents and hearings can continue to be added to the case.

An “inactive” case status ends all names assigned to the case.

This can be a problem if you have a collections person who continues to work with the family to collect fees. There are two possible solutions if this is a problem:

- ❖ You can remove the end date from anyone assigned to the case whose name should remain.
- ❖ We can automatically add a person assigned to the case when this case status is added. (If you choose this option, you will need to let us know whose name should be added.)
